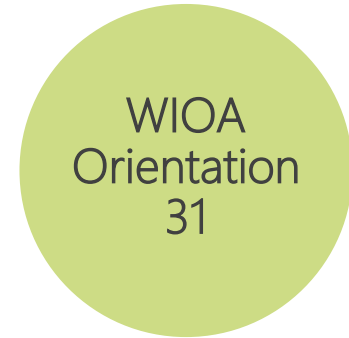
Unemployment Rates

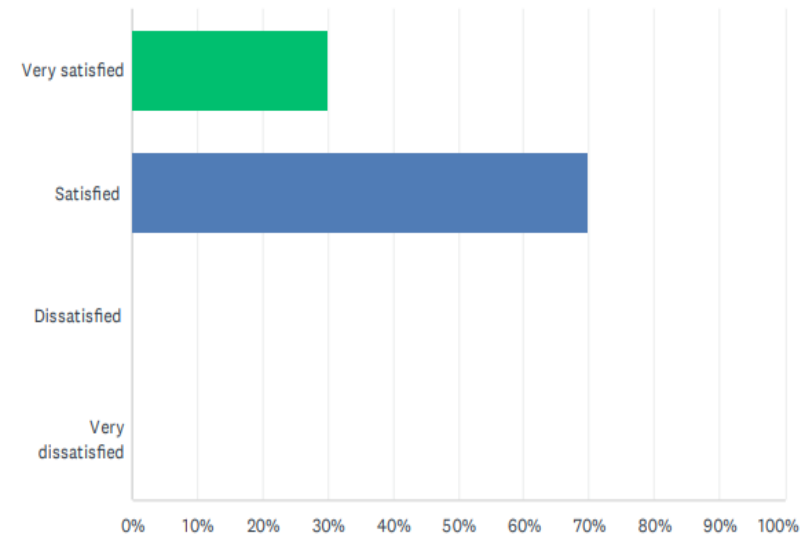

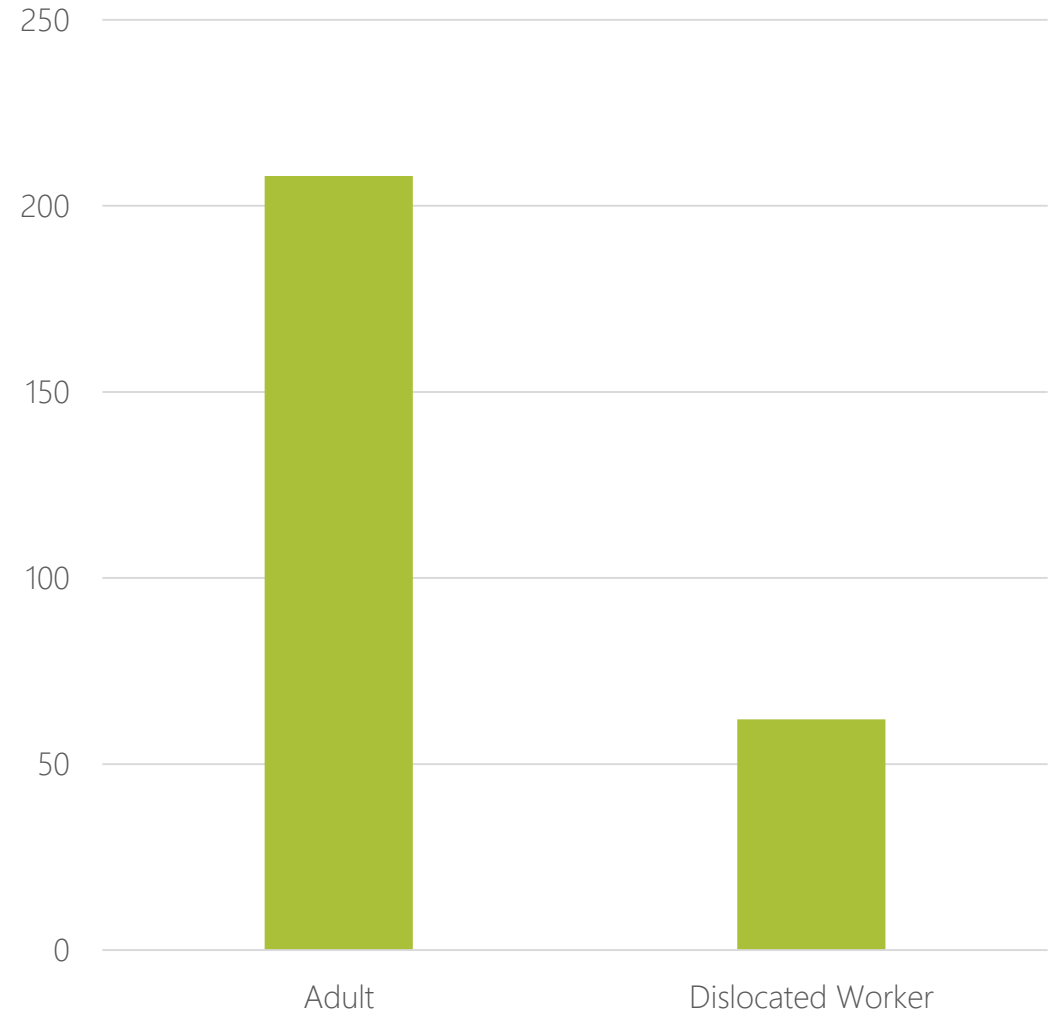

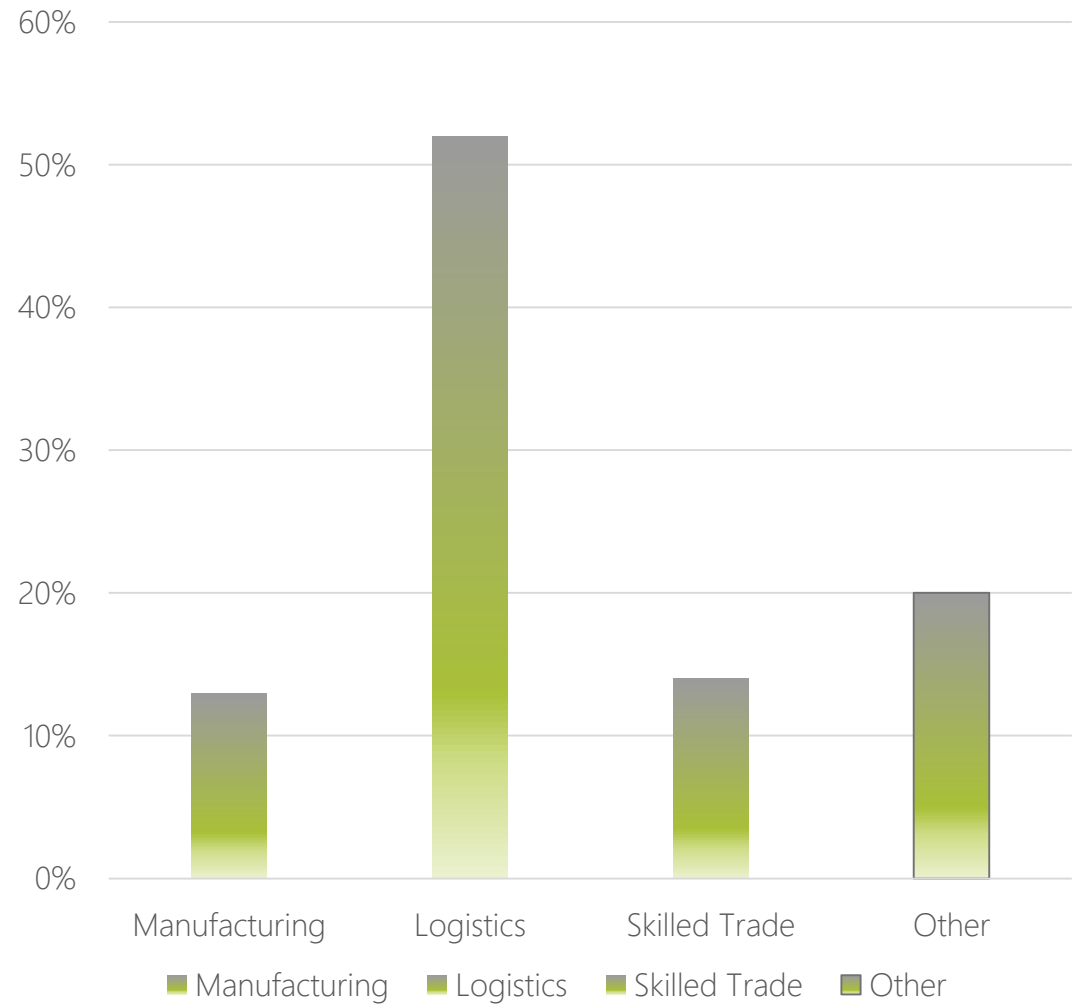
